IV. NUVVE POWERPORT LEVEL 2 AC CHARGERS OR EQUAL SUBSTITUTION CLAUSE:

The deadline to submit an "or equal" request is on or before the deadline of the RFO/P PS23-0300-11, which is 2:00 PM, September 13, 2022. Specifications shall provide a submission of data substantiating a request for a substitution of "an equal" item will include the following: (1) a proposed substitution must be submitted with proposals submission through PlanetBids; (2) notification by the contractor as to how the substituted product will impact the completion; (3) notification by the contractor as to the difference in cost between the substituted product and the listed product; (4) contractor must provide a detailed analysis of the difference between the listed product and the proposed product; and (5) contractor must provide (a) product identification, manufacturer literature, samples, names and addresses of similar projects where the substituted product has been used; (b) and the name and address of the manufacturer's representative.

District shall consider all proposed substitutions during the evaluation process of submittals for RFQ/P PS23-0300-11.
