This meeting is muted for everyone.

If you have a comment question, please raise your hand and you'll be recognized. Once recognized, we will enable your MIC and then on your side we'll need you to unmute to speak when speaking, please be sure to identify what company or union you're with, who you are and who you are directing the question to, whether it be to the sub on the board or whether it be to the GCC specific.

If you do not have a microphone or encounter any glitches, please use the chat feature to communicate with the group to help save time.

We request that the Union reps accept the assignments in the chat, also noting the name of the sub that you're accepting for.

We do understand for recording purposes, having it verbalized is important, so I will be looking at the chat as well and note any acceptances that do pop up before moving on to the next contractor.

So it will be noted on the recording if there are no hands for comments or challenges and no acceptance in the chat by the Union assigned, it is then understood that the assignment is accepted final and will be noted as no comment, no issue in the meeting minutes along with the recording the the chat log in the meeting minutes will be uploaded to the cloud site as well.

So I am Maria Cruz.

The primary contact for the day to day questions regarding the PSA participation for this project.

Also on the call is our wonderful PSA team with let me see. I see.

Ed.

Uh and George and George, of course, is our cherion sensible leader.

He gets involved when there's any substantial matters or issues that arise.

We also want to welcome to today's meeting Samantha Thiesen, our project engineer with our GC Erickson Hall.

So we're now going to review the significance of the pre job conference itself. So the very first thing is that it is mandatory under section 8.5 of the PSA which States and short to avoid jurisdictional disputes.

A pre job conference is required to be held prior to the start of work by all contractors at every level performing work covered by this agreement. The purpose of this is to review scopes and determine crafts to be used. Established manpower estimates giving an idea of the work schedule for the contract, and of course, the project working rules.

Now our Article 16 in the PSA goes into further details describing the activities to take place at this precog conference, noting that all work assignments should be disclosed by each contractor, and if any form of formal jurisdictional disputes between unions on an assignment pop up, they will be noted and I'll review how those are handled in a in a quick minute.

So additionally, the purpose of the pre job conference is to bring together the district.

The GC's are, so they're subcontractors and the unions to ensure everyone is on the same page with scopes and schedules, noting that every contractor with a signed contract or PO, including all levels of tiered Subs, must be identified and are required to sign and submit a letter of assent prior to beginning work.

By the end of this meeting, our goal is that all work assignments will be completed being permanent and final.

So Next up is just a quick review of how the crew set up for our PSA projects work. The PSA implements what is called a composite crew concept, meaning if your company is not signatory to a union outside of these PSA projects and your work requires a crew of two or more, you're required to utilize the using the unions hiring hall for manpower as a non signatory contractor, you're allowed three core workers per trade.

However, per the PSA hearing rolls, core workers will be required to register with the

applicable union and or unions.

If you have that Jack of all trades who performs a little bit of everything per assignment prior to performing work on site.

Now in our section 3.6 of the PSA, the composite crew is made up of a ratio of 1 to 1 core worker to union dispatch worker up to your 3 core workers per trade.

So for crew of let's say 8, you're 3 core workers will be the first third and the 5th workers on site.

The Union dispatch workers must be in the 2nd, 4th, 6th in anything after 6th place being dispatched from a union hiring hall.

When requesting dispatch from that Union hiring home, a contractor can and we always recommend stipulating any specific needs to complete the task, especially for any specialty requirements, specialty work, specialty certifications, equipment etcetera, etcetera.

So depending on the Union, the contractor can request workers by name and can request workers from the districts identified priority ZIP codes.

So the district has goals for employing residents of San Diego County residents within the district's boundaries.

Residents within the districts targeted ZIP codes, which we, which have been identified in the paperwork handed out to the GCS, and the Subs today's meeting each of our contractors will be asked to make a work assignment.

Each sub, including tier Subs, are responsible for making their own work assignments, meaning a GC can't make work assignment for a sub in a sub, cannot make a work assignment for any of their tiers, all Subs to be reviewed today have already completed a pre job forum describing their scope and work assignment. If you are and if you are in this meeting and you haven't already completed the forms, please provide them to this office prior to mobilizing for work and we will get you through this process as well.

The contractor has the right to choose the assignment of scope as long as the Union being assigned claims and accepts that scope.

Once the scope of work is assigned to a craft and or union, it is considered final and can only be changed in one of two ways.

The first, the two unions evolved, discuss in agree to the change or at the direction of an arbitrator through a process that is outside of this meeting, changes other than work assignments such as clarifications on scope, specific extra items that were spoken to but not added into the scope need to be reflected in the pre job form and

will need to be revised and resubmitted right away.

OK, now let's get into reviewing how the meetings gonna go.

Samantha will describe the overall project scope and schedule, noting if Erickson Hall plans to self the form or not.

If they will, then they're going to go into their self performed crews in assignments.

Then I will pull up the sub paperwork in order announcing them one by one.

Each sub if in attendance, we're gonna call your name.

We need you to raise your hand, be recognized.

We will unmute you and then you will need to unmute yourself and then you will describe the scope of work you're gonna be performing.

As noted on the paperwork on the board, then you're announced you're gonna announce your assignments.

So what you mean you're going to be going with, then?

If you're gonna have any tear Subs and then the scope that they're gonna be performing, but that's it.

And then they will do their own forms.

And then of course answer any questions that may arise from the unions.

If a sub is not present, Samantha will read the scope and assignment and answer any questions or take notes of the questions for the sub to respond.

If they are present but there Mic isn't working, Samantha will also read their scope and then they can answer any questions in this in the chat box.

Now, if a Union challenges the work assignment of one of the one of the following scenarios is going to happen.

So the first, of course, is we're going to check to see if the Union being assigned is present and accepts the work as described.

Then, if the Union assigned the work is absent, will note the challenge and ensure the contractors aware of the challenge.

3rd if the sub is absent, the challenge will be noted in.

The GC will notify the sub of the challenge.

Hold on one second.

Let me check this off.

We do like to remind the contractor that the work assignment is 100% up to them as long as the Union assign accepts the work and it is gonna be final at that point.

Work assignments will not be changed as described earlier, unless the two unions agree on it, or an arbitrator orders it, and then to reiterate from earlier to help us

save time during these meetings, we asked that the Union reps accept assignments in the chat.

I will verbally note the acceptance and then it will be added to our meeting minutes as well.

This scope of work does include site upgrades, landscaping and trenching as necessary for required underground utilities serving the scope of the project.

And the new elementary school building.

See, we modernization of building fee relocation of the portable or portable classrooms from the east side of campus to the West side of campus and all structural mechanical, plumbing, electrical, telecommunications, fire alarm and Fire Protection work as necessary to meet the latest building code in DSA standard

standards.

Applicable are gonna be applied for this project scope.






