They will be assisting as well. I I don't believe director George Harris is in.

Maybe he might pop in.

While we're into the meeting, so for RGC, we have Soltech Pacific and I believe it's John Thur.

He will be speaking for on behalf of Soltech today.

I'm gonna go over some teams items. Just the overall rundown. You know, for the procedures here on this meeting.

So the meeting is being recorded and later on, we're gonna upload a recording of the meeting to the PSA cloud to speak it accessible for everybody, everybody.

You're gonna notice you're muted.

All the people are muted, so if you did need to.

Talk. We'll give you the ability to unmute your microphone.

You just have to raise your hand and myself or Maria Todd, George, one of us will give you the ability to unmute your microphone. Go ahead.

And once that's done, you click the little.

Mute a microphone symbol and unmute yourself and go ahead and introduce

yourself who you're with. If you're a contractor for Union Rep, just go ahead and and put that out there before you start asking your your questions or comments. If there are any issues at all with your.

Microphone say when you do get called upon and you cannot get your microphone to to mute or you just having some sort of technical issues. Just go ahead and drop it in the chat.

We're gonna be monitoring the chat as well.

So for the reps as well, we're gonna be monitoring the chat for.

Acceptances and challenges for work assignments.

So please feel free to use the chat to you know, say you're going to accept an assignment, but make sure to put the the company name that you're accepting the assignment for, or if it's a specific group of work that you're that you're claiming challenging, put that as.

Well, and what company you're talking about?

Which contractor is as well. So purpose of today's meeting is we're gonna go over the project scope, schedule and work rules.

This meeting is mandatory.

Under the PSA.

So go for today's meeting.

Is that we're gonna go over the scopes of work individually with the contractors and then the work assignments that they made to the unions. We're hoping at the end of this meeting that the goal is that those work assignments are final and permanent. So after today there are only a couple of ways that the work assignments can be changed.

One is if the disputing parties can come to an agreement and make those changes great, that that would be great.

But if not, there's a process outside the PSC where the disputing parties would meet with an arbitrator who would make those.

Make that order the change, basically, and that's how that goes, so.

For contractors who are not signatory to Union and you do need to use more than one manpower, you are gonna have to utilize the Union hiring halls.

So I'm gonna give you an example how that goes.

Let's just say you needed a crew size of six or more positions 1/3 and five would be your coworkers positions 24 and six would be workers that are dispatched from the Union hall and any manpower beyond six needs to be dispatched from the Union

hall.

So, and it's also very important that you register your core workers.

With the Union hall of their craft, even if you've made your your one guy or gal is covering multiple trades and on your pre trial form you made a Rook assignments to multiple unions and that guy gal's gonna do that.

You need to make sure you register with the local union hall that that for each of those. So feel free to reach out to your local union halls if you have any questions regarding registering of the the core workers.

I'm gonna say that's about it for me.

And like I said, I don't think.

Before we get there, let me give a overview for the Union Rep so that they understand there's a whole site modernization that has been taking place on Baker. This photovoltaic is AP1.

Addition to the whole site modernization that.

Is being handled by Soltech as a separate contract.

The district, it's just a CCD with DSA, so the.

Ancillary work that normally would take place on a job has already been covered by the whole site modernization, and essentially we're gonna get just into the specifics and the scopes related to the PV, which will be as follows.

It's a photovoltaic system.

We will have structural steel foundations.

Pylons for the columns.

Low voltage and high voltage electrical.

And some underground conduit.

And survey those are the only activities that.

Are distinctly associated with the PV that are already part of the whole site.
