

# FIRST AMENDMENT TO MASTER CONTRACT BETWEEN SAN DIEGO UNIFIED SCHOOL DISTRICT AND ENDELOS CONSTRUCTION LLC DBA ENDELOS ENERGY

First Amendment to Agreement PS23-0834-11 is made into and entered by and between the San Diego Unified School District ("District"), 4100 Normal Street, San Diego, California, 92103 and **Endelos Construction LLC dba Endelos Energy**, ("Contractor") a California limited liability company, 593 Avenue of the Flags, Suite 105, Buellton, California 93427 (together sometimes referred to as the "Parties").

WHEREAS, on April 11, 2023, the District's Board of Education approved an Agreement with the Contractor under item I.45 to design and construct battery energy storage systems (BESS) at two (2) district sites, for the period from April 12, 2023 through April 11, 2024, with a total not-to-exceed dollar value of \$4,159,833.50; and

WHEREAS, the District wishes to extend the term for two (2) years and update the labor compliance requirements.

NOW, THEREFORE, it is mutually agreed by the District and Contractor that said Agreement is amended as follows:

- 1. Section 2, "SCOPE OF CONTRACT," "A" is hereby amended to extend the term for two (2) years as follows:
  - a. The total value of this Contract shall not exceed the amount of \$4,159,833.50 (Four Million One Hundred Fifty-Nine Thousand Eight Hundred Thirty-Three 50/100 Dollars) for an initial term of **April 12, 2023** through **April 11, 2026**, with one or more options to extend for a total of three more years.
- 2. Section 36, "LABOR CODE AND OTHER LABOR/WORKFORCE REQUIREMENTS," subsection 36.1.2 is hereby amended as follows:
  - 36.1.2 The applicable wage determination for this First Amendment is **2024-1**. This includes change orders and warranty work relating to this Contract. Copies of the prevailing rate of per diem wages applicable to this Contract may be found on the internet: <a href="http://www.dir.ca.gov/DLSR/PWD">http://www.dir.ca.gov/DLSR/PWD</a>. Rate information and any applicable predetermined increases may be found at <a href="http://www.dir.ca.gov/oprl/dprewagedetermination.htm">www.dir.ca.gov/oprl/dprewagedetermination.htm</a>. Contractor shall post at appropriate conspicuous weatherproof points on the site(s) of the Contract a schedule showing the Prevailing Wage Determinations published by the Director of DIR, which are applicable to the Contract.
