#### 1.10 WARRANTY

- A. Manufacturer's Special Warranty: Manufacturer agrees to repair or replace components that fail in materials or workmanship within specified warranty period. Failures include excessive color change, excessive surface wear, and defects determined to exceed normal weathering and wear of track surfacing, striping and markings.
  - 1. Warranty Period: Five years from date of Substantial Completion.

### 2.2 SYSTEM DESCRIPTION

Retain the first paragraph below for impermeable track surfacing.

A. Impermeable polyurethane synthetic track system comprised of a base layer of pavedin-place polyurethane-bound SBR granules, an impermeable seal coat of twocomponent polyurethane, topped by a structural spray coat of single-component polyurethane and EPDM granules. The average total thickness shall be approximately
