

Advertisement for Bids

Notice is hereby given that the San Diego Unified School District, acting by and through its governing board, will electronically receive bids for the furnishing of all labor, materials, transportation, equipment, and services for:

JOC FLOORING

All bids must be received electronically at or before **1:00 p.m. on OCTOBER 27, 2022**. Firms interested in submitting a bid package must go to tinyurl.com/SDUSD-PlanetBids then search under "Bid Opportunities" for "Invitation number" CP23-0126-52 JOC Flooring. For new vendors, please register under "New Vendor Registration".

The District anticipates awarding to the selected Contractor(s) an agreement with an initial one-year term for an initial total not-to-exceed amount of Five Hundred Thousand Dollars (\$500,000). The Agreement will have the option to increase the initial term for up to two (2) additional 1-year periods. The guaranteed minimum contract value is Twenty-five Thousand Dollars (\$25,000).

This is a PSA project and requires prequalification. The District requires that Bidders possess any of the following classification(s) of California State Contractors License(s), valid and in good standing, at the time of bid opening and contract award: **C-15 or other appropriate license, subject to District approval.**

CONTRACT DOCUMENTS: Each bid shall be in accordance with all terms, conditions, plans, specifications and any other documents that comprise the bid package. **The Bid and Contract Documents may be downloaded free of charge at the new District's online Planroom at sandiegousdplans.com** (click on Public Jobs to view all current bids). Contractors may purchase printed documents at Crisp Imaging for a refundable payment of Five Hundred Dollars (\$500) per set or CD/USB drives for a non-refundable payment (\$2 - \$10). Payments shall be made by check payable to San Diego Unified School District. If allowed, refunds will be processed by the District only if the Bid and Contract Documents, including addenda, are returned intact and in good order to Crisp Imaging within ten (10) days of the issuance of the Final Bid Tabulation. All bids shall be submitted on bid forms furnished by the District. The bid package will be available beginning October 4, 2022. Bid packages will **only be accepted via PlanetBids**. PRE-QUALIFICATION OF BIDDERS: Pursuant to Public Contract Code (PCC) for Job Order Contracting for School Districts §20919.24, each contractor wishing to bid as a JOC prime contractor to the District must be prequalified in order to bid. Prequalification application is attached to the solicitation for a JOC contract and will be available as **Attachment 14 of the bid package on the first date of advertisement. Completed applications must be submitted to the District no later than (October 13, 2022), which is 10 business days before the bid opening due date.** Any questionnaires submitted later than this deadline will not be processed for this Invitation for Bids. The District encourages all JOC Prime Contractors to complete and submit application as soon as possible.

SENATE BILL (SB) 854 REQUIREMENTS: Effective July 1, 2014, no contractor or subcontractor may be listed on a bid proposal, or awarded a contract for a public works project unless registered with the Department of Industrial Relations (DIR) pursuant to Labor Code §1725.5 [with limited exceptions from this requirement for bid purposes only under Labor Code §1771.1(a)]. This project is subject to compliance monitoring and enforcement by the DIR. Refer to the following DIR Website for further information: www.dir.ca.gov/Public-Works/PublicWorks.html

PREVAILING WAGES: Prevailing wage requirements apply to all public works projects and must be followed per Article 17 of the General Conditions of this bid. The applicable wage determination for this contract is 2022-2, and will be 2022-2 for the duration of the contract. This includes amendments, change orders, and warranty work relating to this contract number. DISABLED VETERAN BUSINESS ENTERPRISE (DVBE) PARTICIPATION PROGRAM: Pursuant to Resolution In Support of Service Disabled Veterans Owned Small Businesses (SDVOSBs) and Disabled Veteran Business Enterprises (DVBEs) approved on May 10, 2011 by the Board of Education, the Bidder is required to satisfy a

minimum DVBE participation percentage of at least three percent (3%) for this project. In compliance with this Program, the Bidder shall satisfy all requirements enumerated in the bid package.

Each bid must be submitted on the Bid Form provided in the bid package and shall be accompanied by a satisfactory bid security in the form of either a bid bond executed by the bidder and Surety Company, or a certified or cashier's check in favor of the San Diego Unified School District, in an amount equal to ten percent (10%) of their bid value. Said bid security shall be given to guarantee that the Bidder will execute the contract as specified, within five (5) working days of notification by the District.

WITHDRAWAL OF BID PROPOSALS

Bid Proposals may not be withdrawn by any Bidder for a period of **ninety (90) days** after the opening of Bid Proposals. During this time, all Bidders shall guarantee prices quoted in their respected Bid Proposals. A successful bidder shall not be relieved of the bid submitted without the District's consent or bidder's recourse to Public Contract Code §5100 et seq.
