It out to today's free job. It is for GW Mith, Ed, Center GMP 3.

It is the I believe it's called site redevelopment. Yes, and I'll start off with some introductions.

My name is Ada Vida.

I am the PSA specialist assigned to this project.

Our general contractor today is CW Driver and Matthew is going to be speaking for CW Driver and we have some of the rest of the PSA staff as well.

On the call, but Director Harris is not with us today, so it's just gonna be me. Maria Todd.

And I believe that is is it for the PSA staff but.

So I wanna go over some just general PSA items so.

Purpose of today's meeting is we're gonna review the scope of work schedule and work rules for this project.

One of the primary goals for today is that all the work assignments.

Have been reviewed, they've been made and that their final at the end of this meeting permanent.

After today, there's only two ways that a work assignment can be changed.

One is if the disputing parties can come to an agreement and fix that up, and then the second one is if they cannot come to an agreement, they will meet with an arbitrator who will decide that for them.

So for contractors who are not signatory to a Union and you need to use more than one manpower, you are going to have to utilize the Union hiring laws.

So I will give you an example of how that goes.

Let's say you needed a crew size of six or more.

Your core workers would be working in positions 1/3 and five, and you would have to get get union dispatch workers in positions 24 and six.

Any manpower beyond six needs to come from the Union. This match halls and please make sure all your Co workers are registered with the Union hall that your major work assignment to, even if that Co worker is performing multiple trades and you've made work in the multiple work assignments.

Make sure to register your coworker with each of those those unions. Next, I'm going to go into just some regular sort of teams procedures, so the meeting is being recorded later on, we're going to upload a copy of it to the PSA cloud. All the participants are also.

Being captured automatically and you're going to notice yourself being muted right away.

So when it is time and you do want to speak, you can go ahead and raise your hand and I will give you the ability to unmute your microphone.

And then you just introduce yourself what company you're with or or union you're with and then go ahead. And if you're gonna be a contractor, just review your pre job form. And if you're union Rep, just go ahead and add your ask your questions. But if you're having.

Any microphone issues at all?

He'll let us know if there's something in the chat as far as the chat goes as well. We're gonna be monitoring that for.

Work assignment acceptances.
