The pre job conference for Garfield Air.

Garfield High School air handler chiller replacement with coding construction. So I'd like to start off the meeting by letting everyone know that this meeting is being recorded and a copy of the recording will be uploaded under this project on the PSA cloud site.

So please use the chat feature to check in by letting everyone know who you are, what company or union you're with, and how to get a hold of you again, whether it be a cell phone, an office phone, or an e-mail.

And then we request that all questions.

Also be asked in the chat just for easier tracking as we start this meeting.

Everyone is muted if you have a comment or question, please raise your hand and be recognized.

Once recognized, we will enable you to unmute your MIC and then to speak when speaking.

Please be sure to identify who you are, what company you're from and who you're directing the question to.

So whether it's a question or comment for the GC, or if it's for the sub that we're going.

We're discussing at that moment.

If you do not have a microphone or encounter any glitches.

Please use the chat feature to communicate with the group.

This is gonna be a fairly short meeting. We have 10 contractors that are ready to go right now.

We are in the talks for the next meeting.

So when the next meeting is scheduled, we will definitely put that out along with the recording of the meeting, the chat log in the meeting minutes will also be uploaded to the cloud.

So I am Maria Cruise. The primary contact for the day-to-day questions regarding the PSA participation for this project.

Also on the call is our wonderful PSA.

Team and our ever cherry and Sensible Leader director George Harris, who gets involved when any substantial matters or issues arise. I want to welcome to today's meeting Palin and Adriana.

Palin is our project manager for this meeting and Adriana is our project coordinator with Conan Construction.

So next we're going to review the significance of the pre job conference.

So first thing is it's a mandatory meeting under section 8.5 of the PSA, which states in short.

To avoid jurisdictional disputes, a prejud conference is required to be held prior to the start of work by all contractors at every level performing work covered by this agreement for the purpose of reviewing scopes and determining the crafts to be used.

Establishing manpower needs getting an idea of the schedule of work for the contract, and of course reviewing project, working roles.

Now our Article 16 goes into further details describing the activities to take place at the pre job.

Noting that all work assignments should be disclosed by each contractor, and if a firm, a formal jurisdictional dispute between unions on an assignment does pop up, they will be noted and I'm going to review how those get handled here in a minute or two.

So additionally, the purpose of the pre job conference is to bring together the district, the GC subcontractors tier contractors and the unions to ensure everyone's on the same page with scopes and schedules, noting that every contractor with a signed.

Tracked or Po, including all levels of peers must be identified and are required to sign and submit a letter of assent prior to beginning work on site by the end of the meeting.

Our goal is that all work assignments be complete, being permanent and final. So Next up is a quick review on of our crews set up for the PSA project. So our PSA implements what is called a composite crew concept meaning. If your company is not signatory to a Union.

Outside of our projects, of course your company is required or and your company is using a crew of two or more. You are required to utilize the Union's hiring hall for manpower.

As a non signatory contractor you are allowed three core workers per trade. However, per the upsa hiring rules, core workers will be required to register with the applicable union and or unions. If you have that drag of all trades, it does a little bit of everything per \*\*\*.

Prior to performing.

Work on site now. The 3.6 section of the PSA describes the composite crew as being made-up of a ratio of 1 to one, one coworker to one dispatched worker from the Union up to your 3 core workers.

So if you have a crew of eight, your 3 core workers will be the first, third and the fifth people on site, with the Union dispatch workers being the 2nd, 4th, 6th and then all additional workers after six.

So your seven and eight are gonna be union dispatch.

So when requesting dispatch from the Union hall, a contractor can and should stipulate any specific skills needed or certificates licenses to complete the task, especially for any kind of specialty requirements. Depending on the Union, the contractor can request workers by name and can request workers from the Dist. Identified priority zip codes.

So the district has goals for employing residents within San Diego County. Residents within the district boundaries, and residents within our district targeted ZIP codes, which have been identified in paperwork that's been given out to the GCS. And the Subs at today's meeting, each contractor will be asked to.

Make their work.

Assignment each sub including tier Subs are responsible for making their own work. Assignment. A GC can't make a work assignment for sub A.

Subcassignment for a tier.

Noting that while on our PSA project.

All fringe benefits are required to be paid to the assigned or associated trade unions. Trust that the contractor selects all Subs to be reviewed today will have already completed their pre job form describing their scopes and their work assignments. If you are in this meeting right now and. You have not completed this form. If you do so before the end of the meeting, I can refresh and we can still cover your form.

If not, you'll just be in the next meeting.

The contractor has the right to choose the assignment of scopes as long as the Union being assigned.

Claims and accepts it once a scope of work is assigned to a craft and or union, it is considered final and can only be changed one of two ways.

First, the two unions involve, discuss and agree to the change, or at the discretion of an arbitrator, through a process that is outside of this meeting.

Changes other than work assignments, such as scope of work, clarification need to be reflected on the prerogative form and will be revised and resubmitted right away. OK.

So now let's get into reviewing how this meeting will go.

So Palin will describe the overall project scope and schedule, noting if Conan plans on self performing any work and then describes if that work is being self performed, the scope that will be and the assignments then I'm gonna pull up the sub paperwork in alphabetical order as sh.

On the screen.

So anybody who's not grayed out will be reviewed today.

I'm gonna ask if that sub is in attendance and for them to raise their hand and be recognized.

Once recognized, they will go ahead and speak and read off their scope of work and their work assignments with any equipment, and then identify if they have any tiers. If there's any questions from the unions, they'll go ahead and answer that. Now. If the sub is not present.

Peeling will go ahead and read their scope assignments.

Their scope.

Their assignments and take any questions. If a Union challenges the work assignment, one of the following scenarios.

This is gonna happen.

So first we'll check to see if the Union being a sign is present and accepts the work as described.

2nd, If the Union assigned the work is absent, we'll note the challenge and ensure the contractor's aware of the challenge.

3rd if the sub is absent, the challenge will be noted in. The GC will notify the sub of

the challenge.

We do like to remind contractors that the work assignment is 100% up to them. Again, as long as the Union they're assigning it to does accept the work and it will be final.

Work assignments will not be changed unless unless as described. Earlier, with the two unions discussing and agreeing to it, or an arbitrator orders it. All right, George, is there anything you'd like to add? I'm gonna take that as a no.

And then you guys are planning on performing. So if I can have you read your scopes that you'll be self performing and who you're gonna be giving those to?

We also have some demo scope to handle and some tempnds installation to secure the project site.

For those scopes, we are planning to use labor 89.

Union Local 89 for laborers.

Addition to the laborers, we are also.

So proposing to use.

The Local 619 for some rough carpentry work, we have some blocking to do at the roof level and and some backing and we will be using local 619 for that.

Appreciate that and I'm not sure if those walls are masonry or or they're just wood or whatever materials.




