Good Morning Mark,

Last Friday Dale, Ramon, and myself reviewed the scope of ductwork that the Criteria Architect team has proposed to be painted. I've attached drawings indicating the duct to be painted and the measurements we took for reference. I would kindly ask that Soltek provide the District with a cost proposal to paint the rooftop ductwork proposed by the Criteria Architect team.

The Criteria Architect teams' proposal includes the painting of all rooftop ductwork and duct stands at Bldgs. 02 and 07. Also at Bldg. 07, the RTU curbs and gas flues are to be included in the scope. Most of the ductwork and duct stands are to be included in the scope at Bldg. 05 with the exception of (3) duct runs on the North ridge of the roof.

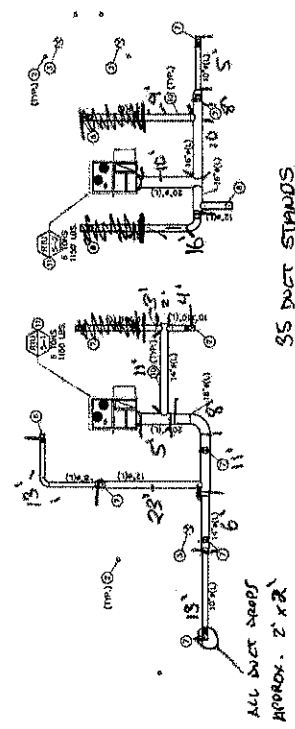

Comments : SDUSD requested a site visit to address complaints from neighbors regarding duct system glare. We did a site visit and we found that in some sections of duct system the glare is blinding and present, we recommend that the sections mentioned below be painted/masked to alleviate current complaints from neighbors.
