Demo AC paving, salvage backstops & remove tree. Strip/stockpile existing DG, cut to subgrade and export. Install drainage, irrigation system, DG drainage section, topsoil & plant sod. Install bio-swale including cobble, planting and headwall. Concrete curbs and stabilized DG for walking path. Install retaining walls, flatwork and stairs at concrete ADA ramp including handrails. Pedestrian ramp & sidewalk for site access from street. Chain link fence and gates to separate campus & joint use area. Install play equipment w/ resilient surfacing and shade canopy. Concrete curbing, DG and trees for various planter areas within the playground. Gravity wall & swale at the lunch area. Asphalt paving, overlay & restripe. Install site furnishings including: drinking fountain, signage, benches, picnic tables, bike racks & trash receptacles. New water and electrical services hookups - to coordinate permitting.
