All the emails that went out earlier yesterday today and the emails that will be following with all the documents, please use the chat feature to check in by to let anyone know who you are, which company you're with and how to go to hold of you again, whether it be it via email or phone number.

And then we always request that the questions be answered or asked in the chat or the Q&A as well, just for easier tracking and response.

And this way they are automatically added into the Minutes as well to be uploaded to the cloud as we start this meeting, everyone is muted.

If you have a comment question, or if you are a sub being called, please raise your hand.

We will be we will recognize you once recognized, we're we're gonna enable your microphone and then you will need to unmute your microphone on your side to speak when speaking.

Please be sure to identify who you are, what company or what union you are with and whom you are directing your questions or comments to.

If you do not have a microphone, or if you encounter any glitches, please use the chat or Q&A feature to communicate with the group when this happens.

Marco, our PM with Belfor will read for you.

So your scope and your assignments and then any additional questions that may occur from the unions we ask you to answer in the chat now to help save time during these meetings, we are requesting that all of our Union reps except assignments in the chat.

We understand that for recording purposes, having it verbally noted is important, so I will be verbally accepting any assignments that are noted in the chat before we move on to the next contractor.

Now, if there are no hands, no comments or challenges, and no acceptances in the chat, it is understood that the assignment is accepted final and will be noted as no comment, no issue in the meeting minutes, and accepted.

Now the chat and Q&A reports will also be uploaded to the cloud for reviewing after the meeting.

So I am Maria Cruz.

The primary contact for the day to day questions regarding the PSA participation for this project.

Also on the call is our wonderful PSA team consisting of and.

I know there's some still at the construction Expo that was going on this morning, but I see George is on and I believe Edison in Todd might be on the rest of our team. I believe Ray and ivory might be joining in a little bit later.

Now, as far as director Harris goes, he gets involved when there's any substantial matters or issues that come up.

Other than that, you'll be dealing with me.

So we do want to welcome today to today's meeting.

Marco, who is our project manager from Belford Beatty and then next we're going to go go ahead and review the significance of the pre job conference.

Of course, the first thing is that it is a mandatory meeting under the section 8.5 of the PSA, which states in short to avoid jurisdictional disputes of pre job conference, is required to be held prior to the start of work by all contractors at every level performing work covered by this agreement for the purpose of reviewing scopes, determining the crafts to be used, establishing estimated manpower needs to kind of get an idea of the schedule when work is going to be rolling out.

And of course, the project working roles now Article 16 goes into further details describing the activities to take place at the conference, noting that all work assignments should be disclosed by each contractor, and if a formal jurisdictional dispute between unions on an assignment pops up, they will be noted.

I will review how those are handled shortly.

Additionally, the purpose of the pre job conference is to bring together the district, the GC, subcontractors tiers and the unions just to ensure everyone is on the same page with scopes and schedules, noting that every contractor with the signed contract or PO, including all levels of tiers or any kind of vendor who's gonna be performing physical labor that is covered under this agreement, must be identified and is required to sign in to sign and submit a letter of a sign.

Now, by the end of this meeting, our goal is that all work assignments will be complete, being permanent and final.

Next up is a quick review of how the crew set up for the PSA projects works.

The PSA implements what is called a composite crew concept, meaning if your company is a non-signatory is not signatory to a union outside of these PSA projects and your company requires a crew of two or more, you are required to utilize the unions hiring hall for manpower as a non-signatory contractor you're allowed three core workers per trade.

However, per the hiring rules, core workers will be required to register with the applicable union or unions.

If you have that Jack of all trades who does a little bit of everything? Uh.

So per assignment prior to performing work on site, now under section 3.6 of the PSA, that composite crew is made up of a ratio of 1 to 1 core worker to union dispatch worker up to your 3 core workers.

So if you're looking at a crew of six, you're you're 3 core workers will be in the first third and 5th workers on site where the Union dispatch workers have to be the 2nd, 4th, and 6th.

Now, if you have a bigger crew than that, all additional workers will need to be dispatched through the Union hiring hall when requesting dispatch from the Union hiring hall, a contractor can and should stipulate any specific skills needed to complete the task, especially if their first specialty requirements like asbestos or a specialty license for any kind of equipment, depending on the Union, the contractor can request workers by name and can request workers from the districts identified priority ZIP codes.

So the district has aspirational goals for employing residents 100% from San Diego County.

Again, aspirational, we do know people do come from other counties, and then the 75% within district boundaries and then that 35% within the districts targeted ZIP codes.

So this information has been identified on the paperwork given to the GC and to the Subs at today's meeting, each contractor will be asked to make a work assignment. Each sub, including tier Subs, are responsible for making their own work assignments.

The GCC cannot make a work assignment for a sub, and a sub cannot make a work assignment for a speed tier.

All sub should have already completed the pre job form describing their scope of work and assignments.

If you are sub currently on the call or a tier currently on the call and you have not completed this form, you can get the form done before we complete this meeting and we can come back to you and review your format that time.

But if it's not done by then you'll have to be rolled to the next meeting, so the contractor has the right to choose the assignment of scopes as long as the Union being assigned claims and accepts it.

Once the scope of work is assigned to a craft or union, it is considered final and can only be changed one or two ways.

Number one is if the two unions involved discuss and agree to the change or at the discretion of an arbitrator through a process that is outside of this PSA meeting now changes other than work assignments need to be reflected in the pre job form and we'll need to be revised and submitted right away.

This comes into play when we're trying to get clarification on scope or if the scope is too vague and it needs to be detailed more.

All right, now let's get into reviewing how the meeting will go.

Umm, I would like when we start, I'd like Marco to describe the overall project scope and schedule, noting if Belfour baby's gonna be planning to work on site, which for this project they're not, so then we'll move into the Subs and now.

You will read your scope, then you're gonna read your assignments and to which

union you're assigning it to.

You're going to identify any tier Subs that you plan on having on the project with you and then we leave it for any questions, comments or concerns from the unions.

Now at the sub is not present.

I'm going to have Marco read the scope and assignment and answer any questions or take note of questions for the Subs to respond to later.

Now, if a Union challenges the work assignment, one of the following scenarios is gonna happen.

Number one, we will check to see if the Union being assigned is present and accepts the described work number 2.

If the Union assigned the work is absent, we will note the challenge and ensure that the contractor is aware of the challenge #3 if the sub is absent, the challenge will be noted in the GC will notify the sub of the challenge.

We would like to remind the contractors that the work assignment of course is 100% up to them and is final as long as the Union you're assigning it to accepts the work now, work assignments will not be changed again unless the two unions agree, or an arbitrator requires it.

So to reiterate from earlier to save time during these meetings, Union reps will accept assignments in the chat.

I will verbally note the acceptance if there is no challenge, no acceptance, then it's just understood that the assignment is accepted and final George.

Anything you'd like to add?

So you'll note that it is a little bit different than the typical one, so we're going to go

into the contract summary, Marco, if I can go ahead and have you read the contract summary.

This is Marco Belford.

Beatty.

Hi everybody so this is an existing high school and Middle college campus for the San Diego Unified School District.

It's an existing four story structural steel building, 3rd and 4th floor is attended improvement work which includes demolition of the walls demo of the MEP and reconfiguration of the spaces for new classrooms and office spaces.

That's on the 3rd and 4th floor, so that work includes new metal stud framing and drywall work.

New ceilings, new flooring work.

Structural steel, seismic upgrades, new mechanical, electrical, fire, fire, sprinkler, fire, sprinkler work and plumbing upgrades on the 2nd floor we have demolition work.

You fire alarm system.

You ceilings new structural steel, seismic work and and then we drop down to the first floor which is similar to the second demolition work.

New fire alarm system, new ceilings, new structural steel.

Seismic upgrades.

Structural Concrete foundation upgrades and new flooring on the exterior of the building.

We have demolition work, plasterwork storefront framing work, metal stud framing, uh, a new exterior stair tower.

Uh.

That includes a concrete foundation, structural steel, metal stud framing, sheathing, plaster and roofing work and on for the site work we have sidewalk upgrades and asphalt paving work.
