Recording has been started. Thank you, Todd.

So I'd like to start off by letting everyone know that this meeting is being recorded and a copy of the recording will be uploaded under the project on the PSA cloud. Please use the chat feature to check in by letting everyone know who you are, what company or union you're with, and how to get a hold of you, whether it be an e-mail or a phone number. And then we request that questions also be memorialized in the chat.

Just for easier tracking.

And to make sure that nothing is missed.

As we start this meeting, everyone is muted.

So if you have a comment, a question, or if you're a a contractor in wanting to speak, please raise your hand and be recognized.

Once recognized, I will enable you to unmute your microphone and then I will let you know to unmute yourself. So the microphone is for all those not as familiar on the top right corner of your meeting screen.

So then we'll ask you to unmute yourself and then to speak.

When speaking, please be sure to identify what company or union you're from, who you are and who you're directing the question to, whether it's to the GC or the sub being reviewed at that moment. If you do not have a microphone or encounter any glitches, please use the.

Chat feature to communicate with the group we have about 10 subcontractors to go through this morning, so our Union reps if you'd like to put your acceptances in the chat, that's always appreciated. If you'd like to raise your hand, that's not a problem

either.

Along with the recording, the chat log in the meeting minutes will all be uploaded into the cloud site.

Now I'm Maria cruise. The primary contact for the day-to-day questions regarding the PSA participation for this project.

Also on the call is our fantastic PSA team as well as our ever optimistic and sensible leader, director George Harris, now director. Harris gets involved when any issues arise or they become substantial or clarifications need are needed.

On our PSA and the interpretation, I want to welcome to today's meeting Peter RPM for Turner and Elizabeth, our labor compliance with Turner.

Next, we're going to go over reviewing the significance of the pre job conference. So the very first thing of course, is that it is a mandatory meeting under the section 8.5 of the PSA, which states in short, to avoid the jurisdictional disputes of Prejud conference, is required to be held prior to the start of work for all contractors at. Every level.

Performing covered work by our agreement for the purpose of reviewing scopes and determining the crafts to be used.

Establishing estimated manpower needs getting an idea of the schedule of work for the contract and of course going over the project, working rules. Our Article 16 goes into further detail describing the activities to take place at the pre job conference, noting that all work assignments should be disc.

By each contractor, and if a formal jurisdictional dispute.

Between unions?

On an assignment pop up, they'll be noted.

Now I'm gonna review how those are handled shortly.

Additionally, the purpose of the pre job conference is to bring together the district, the GC, subcontractors, tiers and unions to ensure that everyone is on the same page with scopes and schedules, noting that every contractor with a signed contract or PO, including all tiered steps, must be ident.

And are required to sign and submit a letter of assent prior to beginning work. So there's a couple contractors.

Currently who have their pre job forms in but not their letters have sent. So before you are permitted to go on the site we will need that letter of assent to ensure that you are compliant with the PSA by the end of this meeting. Our goal is that.

All work assignments are completed being permanent and final.

Now, if you are a contractor that is currently on the call and is noted in Gray or not started or in draft form.

Your forms will not be reviewed during this meeting.

There will be an additional meeting, but if you can get your forms completed prior to the end of the meeting, I can refresh and we can review at that time if you will be needed on site immediately now to explain our expectations of the contractors as a quick.

Review of how the crew is set up for our PSA projects. The PSA implements what is called a composite crew concept. Meaning if your company is non signatory to a union outside of these PSA or PLA projects and your your company requires a crew. Two or more, you are required to utilize the Union's hiring for manpower as a non signatory contractor, you are allowed three core workers per trade. Now with that in per the PSA hiring rules, all Co workers will be required to register to the applicable union or unions if.

You have that Jack of all trades who does a little bit of this, a little bit of that per assignment prior to performing work on site.

And our section 3.6, the composite crew is made-up of a ratio of 1 to one core workers to union dispatch workers up to your 3 core workers.

So if you have a crew of seven, your 3 core workers will have the 1st, 3rd and 5th positions on site, and then the Union dispatch workers must be the 4th or the 2nd, 4th, and 6th, and then all additional workers after six.

Will need to be dispatched from the Union hall so that seventh Guy will also be a union dispatch.

When requesting dispatch from the Union hiring hall, a contractor can and should stipulate any specific skills needed to complete the task, especially for anything requiring special specialty requirements such as and.

I was like these these examples asbestos and having that asbestos certificate, electricians being a state licensed electrician and so on.

Now, depending on the Union, the contractor can request workers by name and can request workers from the districts identified priority ZIP codes.

The district has our goals for employing 100% residents within San Diego County, 70% residents within our district boundaries and 35% residents within our district targeted ZIP codes, which all have been identified in the paperwork given to the GC and Subs and is also.

Noted on the workforce forums at today's meeting, each contractor will be asked to

make a work assignment. Each sub, including tier Subs, are responsible for making their own work assignments.

Meaning AGC can't make an assignment for a sub.

A sub cannot make work assignment for a tier.

Also noting that while on our PSA projects all fringe benefit contributions are required to be paid to the assigned or associated trade union trust.

While hours are worked on this site and then no less than the applicable prevailing wage base rate can be paid to any worker, also contractors to be reviewed today will have already completed the pre job form describing their scope of work.

And their assignments.

And then, like I said, if you're on this meeting and that you see yourself grayed out over here as not started and or in draft, please get in there and complete it.

We will be having another meeting and we can cover you then too. If you cannot do so, the contractor has the right to choose the assignment of scopes as long as the Union being assigned claims and accepts it. Once the scope of work is assigned to a CRA.

And or union it is considered final and can only be changed one of two ways. The 1st way is that the two unions discuss the scope and agree that it does need to be changed or two at the discretion of an arbitrator, through a process that is outside of this meeting. Changes other than work of scope other than work assignments such as SC.

Clarification. If it's just a little bit too vague, need to be reflected on the pre job form and will need to be revised and resubmitted right away.

OK.

Now let's get into reviewing how this meeting is going to go.

I'm going to ask Peter to describe the overall project scope of work in the schedule.

Then I'm going to pull up the sub paperwork announcing them 1 by 1.

I'm going to ask them to go ahead and raise their hand and be recognized.

They're going to be unmuted.

Then they will mute themselves and describe the scope of work that is shown on the screen.

They're going to announce their work assignments, identify if they plan on having any peer Subs, and answer any questions that pop up in the Union.

Now if this sub is not present, Peter will go ahead and read the scope and assignment and answer any questions that he can or take notes for the sub to

answer later. If a Union challenges the work assignment, the following scenarios will happen.

We'll check to see if the Union being assigned is present and accepts the work described, and then we'll note as a challenge if the Union assigned the work is absent. We'll note the challenge and ensure that the contractor is aware of the challenge.

Then if the sub is absent, the challenge will be noted.

The GC will notify the.

Sub of the challenge we do like to remind contractors that the work assignment is 100% up to them and again, as long as the Union being assigned accepts the work and then it is considered final work assignments will not be changed unless as described earlier the.

Two unions agree, or an arbitrator order same, and then George, is there anything you'd like to add?

The schedule is a 28 month project schedule approximately.

With major construction activities commencing on site around June 30th.
