SUBJECT: Bid No. CZ-16-0977-29 Whole Site Modernization at Miller Elementary School - Substitution Hearing Result

On April 10, 2017 the District held a hearing regarding Balfour Beatty Construction's request for substitution of T S I Company for the ceramic tile portion of the work on the project at Miller Elementary School after T S I Company objected to the substitution.

Based on the correspondence submitted by Balfour Beatty Construction and T S I Company and the evidence presented by both companies at the hearing, the District approves the substitution. Based on this information in his bid, the tile subcontractor referenced the plan detail that requires the Sika product. The "add" he listed in his bid for the mortar bed did not specifically mention which product he planned to include or exclude, therefore inferring the Sika product was included. While this may not have been his intent, it is what his bid document conveys.

After review and consideration of all information submitted to the hearing panel the District feels the substitution is warranted and approved and in compliance with Public Contract Code 4107(a).
