SUCH OBLIGATION TO BE A PARTY AND BOUND BY THIS AGREEMENT SHALL EXTEND TO ALL WORK COVERED BY THE AGREEMENT UNDERTAKEN BY THIS COMPANY ON THE PROJECT PURSUANT TO SDUSD CONTRACT No. CS-11-0130-29 MODERNIZATION OF ATHLETIC FIELD FACILITIES AT MORSE HIGH SCHOOL AND THIS COMPANY SHALL REQUIRE ALL OF ITS SUBCONTRACTORS OF WHATEVER TIER TO BE SIMILARLY BOUND FOR ALL WORK WITHIN THE SCOPE OF THE AGREEMENT BY SIGNING AND FURNISHING TO YOU AN IDENTICAL LETTER OF ASSENT PRIOR TO THEIR COMMENCEMENT OF WORK.
