It's for a second session.

Morse High School CTE.

Umm, we had our first session, I believe about roughly a month and 1/2 ago and it was just a handful of.

So I was I needed to start right away, but this will be the the remaining Subs.

We're gonna have just over 40, so going to try and just, you know, keep it, keep it steady, keep it moving along.

I'll start off with introductions.

My name is Ed Davida, the PSA specialist assigned to this project.

I'll be the first point of contact if any needs for this project.

Some of the other PSA staff are also on the line as well.

Director George Harris, Maria Cruz Todd Ether Richard on this meeting as well for our GC team.

It's gonna be nasty.

Evens and Mark will be speaking for Ma Stevens, and this meeting is being recorded.

Wanna let you guys know that and afterwards we're going to upload a copy of the recording to the cloud for reviewing purposes.

I'm all the participants are.

They're being captured automatically.

So as I mentioned before, we have quite a bit of contractors.

We'll be monitoring that and we'll enter that in.

So just try to kind of get this going again.

Things smooth.

So purpose of today's meeting is going to go over the scope schedule and the work rules for the project.

We just want to make sure that everybody is on the same page for the the snacks bulk of the work starts.

So the goal for today's meeting is that we've made all the work assignments and that the work assignments are done and final permanent.

So after it today, there's only two ways the work assignments can be changed.

One is if the disputing parties can come to some agreement resolution and then make that change, and if there is no change there, the other part would be the two parties meeting with an arbitrator who will decide the in order that change for them. And of course, any change does need to be made in writing off for Subs who are not signatory to Union.

If you are going to be using more than one manpower, you are going to have to use the Union hiring halls and I'll give those details right now.

So say for example, if you needed a manpower crew manpower of six.

Uh, your positions 1/3 and five would be your core workers.

Positions 2, four and six would be dispatched from the Union halls and any manpower beyond six would have to be dispatched from the Union halls.

Now, please keep in mind as well very important to register your core workers with the Union Hall of the Craft.

Even if you've made multiple work assignments, that and that core worker is going to be doing those, those that work, they have to register with each of those union halls, and they can't just go down there, make sure they're registered, get in touch with the dining hall, register your core workers.

That's about it.

I've gone over everything.

I think it's pretty good and I'm gonna see if, George, you want to add anything before we pass that along to to mark with the Stevens.

It's a concrete foundation.

It's all steel building, one story.

The greenhouse is prefabricated off.

Site comes on site and just bolts together.

Ohh, there's quite a bit of a concrete site work that surrounds the building.

Been saying there's quite a bit of fencing that goes around the building and that's about sums it up.

It's in case with metal sheet metal.

She metals so sheet metal panel.

There's no wood on this project.

I understand that, but when you say light steel construction, I understand that there's a framing aspect to that which the iron workers would put together.

The light steel construction.

But you're telling me that this is an open building that allows breeze to go completely through it?

There's no sheathing whatsoever, regardless of the material.
