Of the agreement, also on the call with us are my PSA colleagues.

They'll be helping me to run this meeting today.

Today's meeting is a required meeting according to sections 8.5 and 16.1 of the PSA.

One of the reasons for today's meeting is to help avoid jurisdictional disputes.

By announcing the scopes of work.

Also, another intent of the meeting is it's an opportunity for the.

The contractors in the unions to come together and discuss scopes of work and manpower.

Keep in mind that the making of a work assignment belongs to the contractor who is actually performing the work.

If you're a subcontractor, you've hired a tier.

You would indicate who your tiered contractor is, but the and leave it for the tiered contractor to explain how they intend to carry out their work.

Again, once an assignment is made, it's considered final.

There's only one of two ways to alter a work assignment after it's after it's been announced, either the affected contractor and the affected unions come together and alter the work assignment, or through a process called the plan for Jurisdictional dispute, which is handled away from the PSA it.

A separate process today's meeting will be recorded and uploaded to the PSA cloud. A little bit later.

Today we ask that everyone identify themselves in the chat.

A little bit about the PSA, all contractors.

Regardless of tear, must submit a signed letter of assent before they can start work, as well as submit a work assignment.

The PSA falls under a hierarchy which is the state of California.

Rules and regulation, prevailing wage codes and that sort of thing.

Then comes the PSA.

And then the schedule A or the master Labor Agreement that you're working on? Under any subject that's covered in the PSA, you take direction from there. If there's a topic or subject that's not mentioned in the PSA, you have to go to the master, to the schedule A for resolution or for answers.

An example would be show up pay nowhere in the PSA. Does it speak about show up pay.

So you got to go to the separate schedule way to.

Get information about show up pay.

On non union, contractors must have their core employees referred.

Back to the project before they can start work.

So they have to go down to the Union hall that you're working with.

Start a.

Trust account and anyway you work with the Union hall that you on that.

The San Diego School District has a local hire goal that local hire goal is that 100% of the workforce lives somewhere in the county of San Diego.

70% of the workforce live in the school district. Zip code, 35% live in the 11 targeted ZIP codes.

How? We asked the contractors to help us effectuate that goal.

Is that your core employees?

Live somewhere in the county of San Diego, then in a situation where you're I have more than one worker working at a time or the operation of more than one piece of equipment at at the same time, you're likely to have a composite.

Crew. So with your composite crew, you're gonna have to request dispatch from the Union hall.

I mentioned composite crew a minute ago, so non union contractors.

You're you're allowed up to three core employees.

Per contract per classification.

So if you had a workforce of 6.

Positions 1/3 and five would belong to the contractor. 246 and beyond would be would belong to the unions and if you reduced your workforce it would go in reverse order where the position 1 core employee would be the last worker on the site a time.

Referral is that you have your your core employees.

And or.

Your dispatched union members dispatched to you or registered within at least 48 hours less weekends and holidays before the start of the project.

That's a timely referral.

Neither the contractor or their employees are required to join a union to perform under the PSA.

They simply have to follow the guidelines of the PSA.

And schedule A that they're working under.

The wage determination for this project is found at on the DIR website and it is the ways of determination that was in that had been issued during the first advertisement bid. So it's listed on the on the advertise for bid, which weighs very termination to utilize one other.

Thing is, with the prevailing wage, you'll pay the base rate on the check.

And the fringe benefit component will go to the.

This is the third.

We have 3 projects on this job.

The whole site modernization, a joint use field and a solar aspect.

So this is the solar job. It's strictly in the center of the campus and we are essentially drilling for column footings, setting rebar cages.

Pouring concrete and then the the canopies are consist of structural steel with solar panels on top of them, and then we run trenching.

From an existing building 200, which is nearby all the way to those canopies.

So there will be a mild.

Mild repairs to the existing building, like mild painting, repairs and roofing repairs, which is why you'll see some of those Subs on this project conference.

But the majority?

Of it will be our structural steel sub and then the the company actually putting the cages in the ground and pouring the concrete which is Keller and then precision

Electric will be doing the actual solar panels themselves.

And no, we do not self perform any work.

Balfour Beatty.

So all our Subs will be performing this work.
