Today's meeting is a required meeting, according to section 8.1 and 16.1 of the PSA. One of the purposes for having the meeting.

Is to try to resolve any issues before they arise.

It's also an opportunity for the contractors and the unions to get together and discuss scopes of work and manpower. Keep in mind that the.

Making work assignment.

Their assignment of work falls on the contractor who's actually performing the work, not the general. Not a sub, but the actual contractor performing the work.

One of our intents today is to finalize, once we call out the work assignment to try to finalize it once a work assignment's been stated, there's only one of two.

There's only two ways you can alter work assignment. One of the ways would be for the two affected.

Excuse me. The two affected unions and the contractors to come contractor to come together.

And alter the work assignment or for the affected unions to go to the the plan plan for jurisdictional dispute, which is handled away from the the PSA Today's meetings recorded.

We ask that you raise your hand to unmute yourself, to speak.

We also ask that you identify yourself and your organization in the chat.

So that you can be contacted later.

Umm, a couple other things about the PSA. All contractors, regardless of tier, must sign a letter of assent.

Submit a signed letter of assent and a work assignment before they can start work. Non union contractors will have to have.

Their core employees referred back to the project.

The definition of a core employee is a employee that's been on your payroll 30 out of the last 180 days.

They possess any any certification or skill set needed.

To perform the work and that they live somewhere in the county of San Diego. Again, the workers have to be referred back to the project before they can start work. And that's through the Union or Union.

So we working with another component of the PSA is a local local hire rule that local higher rules.

Goal is that 100% of the workforce live within the County of San Diego.

70% live in the school district. Zip code, 35% live in an 11 targeted ZIP code.

How the contractors help us to effectuate that, that goal is that not only do your workers live somewhere in the county, but when you request dispatch from a Union, not only do you point out if you want a journeyman or an apprentice, the skill set or certification des.

But also we ask that you ask for some, if possible, for someone who lives in the ZIP code school district ZIP codes.

Any contractor, non union contractor perform performing work whose scope of work requires either more than one person working at the same time, or the operation of more than one piece of equipment they're likely to have a composite crew.

An example of a composite crew is if you had a workforce of 6.

Three would be your core employees, so positions 1/3 and five would be your core employees where 246 and beyond would be dispatched from the appropriate union hall.

An appropriate request for dispatch is at least 48 hours less weekends and holidays before the start of work.

For either the register your core employees or request dispatch from the Union, I'd like to remind everyone that neither the contractors nor their employees are required to join a Union to perform under the PSA.

They simply have to follow the requirements of the PSA as well as the schedule A or master Labor agreement they're performing under the prevailing wages that are paid.

This is a prevailing wage project. The project the the applicable prevailing wages

were.

The the falls under the wage determination that was in effect during the time of bid. One other component I want to remind you of.
