Please be sure to identify who you are, what company you are with the Union, what company or union, and then umm, who you're directing the question to.

So if it's a Union asking a question to the current sub or to the GCC, or if it's anybody else asking a question to anybody else.

Now, if you don't have a microphone or encounter any kind of glitches, we ask that you use the chat feature to communicate with the group and answer any questions. What if that happens, Dave, as the GC will read for the sub to help save time during these meetings, we do request that our unions accept the assignments in the chat whenever possible.

We understand that for recording purposes, having it verbally noted is important, so I will note the acceptance before moving on to the next contractor and if there are no hands or comments for a challenge and no acceptances in the chat, it's understood that the assignment is accepted final and will be noted as no comment, no issue in the meeting minutes.

The chat Q&A feature in meeting minutes will all be uploaded to the cloud for

review, so I am Maria Cruz.

I am the primary contact for the day to day questions regarding the PSA participation on this project.

Also on the call as our wonderful PSA team, including Ivory Anderson at Avila, Todd Etheridge and I'm not sure if raise on there, but also is our very cheering, sensible leader George Harris, who gets involved when any substantial matters or issues arise. We want to welcome today to today's meeting Dave Williams, who will be the project manager for straight line on this site.

So next we're just gonna go into reviewing the significance of the pre job conference itself.

So of course the first thing is that it's a mandatory meeting under the section 8.5 of the PSA, which states in short to avoid jurisdictional disputes, a pre job conference is required to be held prior to the start of work by all contractors at every level performing work covered by this agreement.

For the purposes of reviewing scope, determining the crafts to be used, establishing manpower needs kind of getting that idea of the work schedule.

And of course, the project working roles now Article 16 goes into some further detail describing the activities to take place at this pre job conference, noting that all work assignments should be disclosed by each contractor, and if a formal jurisdictional dispute between unions on an assignment does pop up, it will be noted.

And then I'm going to review how that's handled shortly.

Additionally, the purpose of the pre job conference is to bring together the district, the GC, the GC Subs, and the Union to ensure everyone is on the same page with scopes and schedules, noting that every contractor with a signed contract and or PO, including all tiered Subs must be identified and is required to sign and submit a letter of assignment.

By the end of the meeting, our goal is that all work assignments be completed, being permanent and final.

So Next up, just a quick review of how the crew set up for our PSA projects works. The PSA implements what is called a composite crew concept, meaning if you're a non signatory contractor, umm, outside of this you know non signatory as far as you're not union outside of these PSA projects your and your work requires a crew of two or more.

You are required to utilize the Union hiring hall for manpower as a non union contractor, you're allowed three core workers per trade.

However, per the Union or per the PSA hiring rules, core workers will need to be registered with the applicable union and or unions.

If you got that Jack of all trade who does a little bit of everything per assignment prior to performing on the job site now under the 3.6 in the PSA, a composite crew is made up of a ratio of 1 to 1 core worker to union dispatch worker.

So if you have a crew of six, your 3 core workers will be the first person, third person, and 5th person on site, and then the Union dispatch workers need to be the 2nd, 4th, and 6th and then all additional workers after that will then be dispatched from the Union hall when requesting dispatch from the Union hall, a contractor can, and we always recommend stipulate any specific specialty needs certificates.

Licenses that will be needed to that will be needed for the worker you're requesting. Depending on the Union, the contractor can request workers by name and can request workers from the districts identified priority ZIP codes.

The district has our aspirational goals for employing residents of San Diego County residents within the district boundaries and then residents within our district targeted ZIP codes, which have been identified in the paperwork to the GC's and the Subs. So at today's meeting, each contractor will be asked to make an assignment to make a work assignment.

Each sub, including tier Subs, are responsible for making their own work assignment, so a GCC cannot make a work assignment for a sub and a sub cannot make a work assignment for a tier.

All sub should have already completed the pre job form describing their scope and work assignments.

If you're a sub on the call and you haven't completed the form, if you can get it in before the meeting's done, we'll review it.

Otherwise, we'll have to send it out later, so the contractor has the right to choose the assignment of scopes as long as the Union being assigned claims and accepts it. Once the scope of work is assigned to a craft and or union, it is considered final. Can only be changed one of two ways.

Number one is if the two unions evolved, discuss and agree that it needs to be changed or #2 at the.

This is the direction of an arbitrator outside of this PSA meeting.

Changes other than work assignments need to be reflected in the pre job form and will need to be revised and resubmitted right away.

All right, now let's get into how this meeting is going to go.

I'm going to have Dave described the overall project and schedule noting if straight line plans and self performing and then covering their self perform work then I will put up the Subs paperwork in order.

Each sub I'm going to ask if they're here, please raise your hand and be recognized, and then you're going to describe your scope of work and your work assignments.

And then if you have any tears, then it's open to the unions to ask any questions and if any sub is not attend in attendance, Dave with straight line, we'll read their scopes and assignments and answer any questions that do pop up.

If Dave's unable to answer question, he will really it back to the sub for response to the everybody later.

Now, if a Union challenge is the work assignment, one of the following scenarios is going to happen.

Number one first, we're going to check to see if the Union being assigned is present and accepts the work as described 2.

If the Union assigned the work is absent, will note the challenge and ensure the contractor is aware of the challenge.

Three, if the sub is absent, the challenge will be noted in.

The GC will notify the sub of the challenge.

We we do like to remind the contractor that the work assignment is 100% up to them and is final.

Work assignments will not be changed unless, as discussed, the two unions agree.

Or arbitrator orders it.

And just to reiterate from earlier, to help save time, we really appreciate acceptances being in the chat, which I will read to make sure that it's recorded.

And then George, do you have anything you'd like to add?
