The photovoltaic system consists of solar modules, racking, inverters, AC electrical collection system, perimeter fence, and small concrete pad. The scope of work includes the following processes: site survey to lay out offset staking for the locations for the driven piles and fence posts; underground line locating and marking; provisions for a hose-wash system; driven steel H-piles; assembly of light gauge steel beams and purlins; array wiring; installation of inverters; wiring of inverters to AC collection panel; directional boring and</p>

trenching; data and spare conduits; installation of concrete equipment pad; installation of data acquisition system and monitoring system.
