**SENATE BILL (SB) 854 REQUIREMENTS:** No contractor or subcontractor may be listed on an RFQ/P or awarded a contract for a public works project unless registered with the Department of Industrial Relations (DIR) pursuant to Labor Code §1725.5 [with limited exceptions from this requirement for bid purposes only under Labor Code §1771.1(a)]. This project is subject to compliance monitoring and enforcement by the DIR.

**PREVAILING WAGES:** Prevailing wage requirements apply to all public works projects and must be followed per Article 17 of the General Conditions of this RFQ/P. The applicable wage determination for this contract is 2024-2 and will be 2024-2 for the duration of the contract.
