On the call with us is director Harris, Director. I'm the day-to-day person director Harris becomes involved when we have higher echelon issues such as interpretations of the agreement. Also on the call with us is my PSA colleagues. They'll be helping me run the meeting today to.

Today's meeting is a required meeting, according to section 8.5 and 16.1 of the PSA. One of the purposes of today's meeting is.

To it's an opportunity for the unions and the contractors to come together and discuss manpower in scopes of work.

Keep in mind that the assignment of work making a work assignment belongs to the contractor that's completing the work.

For example, if you were a subcontractor and you hired a tiered contractor, that tiered contractor needs to make.

Their own work assignment. Once the work assignment has been announced, there are only two ways of altering a work assignment.

One is the two affected unions and the contractors come together and alter it or through the plan or through the plan for jurisdictional Askew.

So either through the the involved parties coming together or through the plan for jurisdictional dispute, which is handled away from the project.

Today we have 3 contracts.

This is solar group F3 contracts, which is Carson.

Oak Park and the supply Center Oak Park and supply.

Center are are identical, so we're hoping to only have to show one page, but I have all three at the ready. Today's meeting is recorded.

We ask that you identify yourself who you're with in the chat when you have a question, we ask that you raise your hand and unmute yourself.

We ask that you record your question in the chat so that it's memorialized.

All contractors must submit a signed letter of assent.

And a work assignment before they can start work on a project.

Where where a matter is addressed in the PSA, you follow the PSA, if there's a matter that's addressed.

So if the matter is addressed, then the PSA.

Follow the guidelines of the PSA.

Always keep it in mind too, that in the hierarchy, see it's the state of California, the PSA and then the schedule.

Way and that's that's how you follow issues.

You'd go to the schedule a a lot of times for issues such as show up, pay the show up. Pay is not listed in the PSA, so you got to go to the individual schedule way to find out finances for that.

All non union contractors are required to have their core employees referred back to the project.

A core employee is described as someone that's been on your payroll.

Out of the last 180 days, they possess the skill set or the certification for the work being performed and that they live somewhere in the county of San Diego, San Diego Unified School District has a local higher goal.

What that goal looks like is it 100% of the workforce lives somewhere in the county, 70% live in the school district, ZIP code and 35 live in the target, 11 targeted ZIP

code.

How the contractor help?

Us to effectuate or meet that goal is that your employees live somewhere in the county, but also if you have a scope of work which requires more than one one worker at a time, or the operation of more than one piece of equipment, then you're likely to.

Have a composite crew and when you make the request for dispatch from the Union, not only are you gonna list if you need a journeyman or or.

Apprentice and the skills.

But also we ask that you ask for someone who lives in the school district, ZIP code that you're working at.

That's how you help us with our goal.

I briefly mentioned a composite crew, non union contractors, again with more than one person working at a time or operating more than one piece of equipment at the same time will likely have a composite crew.

An example of a composite crew is if there were six workers positions 1/3 and five. I would belong to the contractor position 246 and beyond would belong to the dispatching Union and if you were to reduce your crew it would go in reverse order so that the core employee in position one would be the last person on the project a time.

Request for dispatch or red or registration of the core employees is at least.

At least 48 hours less weekends and holidays from the time you need the dispatch.

Keep in mind that neither the contractor nor his employees are required to join a union to work under the PSA.

They have simply have to follow the guidelines of the PSA in a schedule way. They're working under because this is the prevailing wages that are paid on this project are found on the Di Rs website and it's based on the 1st bid advertisement date. That's where you're going.

To find the required wages. Because this is a part private agreement.

With the prevailing wages, you'll pay the base rate on the check and you'll separate the fringe benefit that be sent to the applicable Union trust fund at a later date.
