Phone number, office or cell. And then we request that any questions be asked under the chat as well for easier tracking or if you have something super detailed when we get into the scopes of work that you'd like added, changed or clarified, go ahead and throw that in.

The chat as well. So as we start this meeting, everyone is is muted. If you have a comment or question, please raise your hand and be recognized. Once recognized, we will enable you to unmute your microphone to speak.

When speaking, we ask that you identify who you are, what company you're with and who you're directing the question to, or the comment so whether it be to the sub that we're looking at or to the GC directly.

If you don't have a microphone or encounter any glitches, please use the chat feature to communicate with the group and you can note that currently, as we're going through, if you have any mic issues.

To help save time during the meeting, we do have quite a few contractors who request that our Union reps.

Accept the assignments in the chat if possible, or where possible, also noting the subname to who you're accepting for.

So when we go back through, everything's nice and lined up. We do understand for recording purposes.

Have it having it verbally noted is important.

So I will note the acceptances before moving on to the next contractor. If there are no hands or comments or challenges or acceptances, it is understood that the assignment is accepted final and will be noted as no comment, no issue in the meeting.

Minutes, along with the recording, the chat log and the meeting minutes will be uploaded to the cloud. So I am Maria Cruise.

I am the primary contact for the day-to-day questions regarding oh, excuse me, the PSA participation for this project. Also on the call is our wonderful PSA team and of course, our cheery and sensible leader, director George Harris.

Who gets involved when any substantial matters or or issues arise?

We want to welcome to today's meeting Dennis Daily, our PM with level 10 construction.

Next, we're going to go over the significance of the pre job conference itself. So the first thing is of course it's a mandatory meeting under section 8.5 of the PSA, which states in short to avoid jurisdictional disputes. A pre job is required to be held prior to the start of work by all contractors at every level.

Performing covered work by this agreement for the purpose of reviewing scopes and determining the crafts to be used.

Establishing manpower means and getting idea of the schedule of work, and then of course going over the project working rules for the district.

Now our Article 16 goes into further detail describing the activities to take place at the pre job conference, noting again, all work assignments should be disclosed by each contractor, and if there's any formal jurisdictional dispute between unions on an assignment as they pop up, we will note and.

I'm going to go into details how those are handled.

Additionally, the purpose of the pre job is to bring together the district, the GC, subcontractors tiers and the unions to ensure everyone is on the same.

Scopes and schedules, noting that every contractor with a signed contract or PO, including all levels of tiered subcontractors, must be identified and are required to sign and submit a letter of assent prior to beginning work by the end of the meeting. Our goal is that all work assignments will be completed being permanent and final.

So next step is a quick review of how the crew set up our PSA projects works.

The PSA implements what is called a composite crew concept meaning.

Your company is not signatory to a union outside of these PSA projects and your your work requires a crew of two or more.

You are required to utilize the Union's hiring hall for manpower as a non signatory contractor, you are allowed three core workers per trade. However, per the PSA hiring rules, core workers are still required to be registered with the applicable union and or unions. If you got that.

Jack of all trades who does a little bit of everything.

Per assignment.

Prior to performing work on site now in our 3.6 section of the PSA, the composite crew is made-up of a ratio of 1 to one coworker to union dispatch worker up to your 3 core workers.

So if you have a crew of eight, your 3 core workers will be the first, third and 5th workers on site. The Union dispatch workers must be the 2nd, 4th, and 6th. All additional workers after six, so that seven and 8th will need to be.

Union dispatched from the halls.

When requesting dispatch from the Union hiring call, a contractor can and should stipulate any specific needs to complete the task, especially if there's any specialty requirements for certifications or licensing. Depending on the Union, the contractor can request workers by name and can request workers from the district's.

Identified priority zip codes. The district has goals for employing 100 residents of San Diego County.

Residents within our district boundaries.

And residents within our district targeted ZIP codes, which have been identified on paperwork that's been given out to the GC and to the Subs. At today's meeting, each contractor will be asked to make a work assignment. Each sub, including tier Subs, are responsible for making their own work.

Assignments AGC cannot make a work assignment for a sub sub can't make a work assignment for a tier.

Also noting that while on our PSA projects all fringe benefits are required to be paid to the assigned or associated trade unions.

Trust.

All Subs to be reviewed today will have already completed a pre job form describing their scope of work and assignment.

And if you are in this meeting and you have not already completed the form, please do so prior to the close of this meeting or prior to mobilization.

We're going to be having one more meeting after this to wrap up the remaining contractors. The contractor has the right to choose the assignment of scope as long

as the Union being assigned claims and accepts it. Once the scope of work is assigned to a crafter union it.

Is considered final and can only be changed one of two ways.

Number one, if the two unions involved discuss.

And agree that to the change or at the discretion of an arbitrator, through a process outside of this meeting, changes other than work assignments, such as clarifications on scopes of work or equipment need to be reflected in the pre job form and will need to be revised and.

Resubmitted right away.

OK.

Now let's go into let's go into reviewing how this meeting will go.

Dennis will describe the overall project scope and schedule, noting if level 10 plans on self performing, which he did in the first meeting.

Then I'm going to pull up the sub paperwork announcing them 1 by 1.

Only Subs that are noted not in Gray.

So everybody who's published and or resubmitted will be reviewed.

Each I'm going to ask if the sub is here.

They will raise their hand and be recognized.

And then each sub will describe the scope of work they're going to be performing, announcing their work assignments, identifying any tier Subs, then after any questions from the Union, we'll move on to the next set.

Now the sub is not present.

Dennis will read the scope and assignment and answer any questions.

Or take notes of questions for the sub to respond to later. If a Union challenges the work assignment, one of the following scenarios is going to happen first.

We'll check to see if the Union being assigned is present and accepts the work as described.

2nd, If the Union assigned the work is absent, we will note the challenge and ensure the contractor is aware of the challenge third.

If the sub is absent, challenge again will be noted in. The GC will notify the sub of the challenge.

We do like to remind the contractors that the work assignments are 100% up to them. Again, as long as they assigning the Union as they are finding the work to does accept that work and it will be fine. Work assignments will not be changed as descri. Earlier, unless the two conditions apply or in one of the two ways the two unions

agree and or trader orders A, so just to reiterate, to help save some time during the meeting, if we can ask our Union repres.

To accept in the chat for any assignments, I will verbally note those acceptances and we will go from there.


