Dear Sir,

I am writing this letter in regards to the above as to explain why Laborers LU 89 is being utilized and required for the Mira Mesa HS project and not requested at all for the Pacific Beach MS project.

As you are aware, we have been sub-contracted to install permeable pavers at both of the above mentioned projects. However, there is a substantial amount of difference in the scope of work that is required by us on both of the above. Normally our scope entails the installation and spreading of base and aggregates as it does at Mira Mesa HS, in which case Laborers LU 89 is required to dispatch its trade as it falls within there scope of work. In the case of Pacific Beach MS, all base and aggregate was placed prior to us beginning our installation of pavers. The 1-2" of bedding aggregate at Pacific Beach is installed by a bobcat which falls under the Operators Engineers Union. From there, the permeable pavers are installed by our core employees and members of the bricklayers Local 4. At no point, as far as I can tell, there is a requirement or need for any Laborers to be on this job site. I will agree that for the Mira Mesa HS project, once we are required to start work, Laborers Local 89 will be required for this project. At that point, it is our intent to request Laborers.
