If field Turp is not signatory to specific union and they are going to utilize one more than one manpower, the Union hiring halls will have to be utilized.

So give an example how that goes.

Crew size of six or more is an example.

Positions 1/3 and five would be registered core workers positions 24 and six would have to be manpower that's dispatched from the Union hall.

Any manpower beyond six does need to be dispatched from the Union hall, so make sure that for field turf that all your coworkers are registered with the Union halls that you made work assignments to in your pre draft form.

And if you know, I don't believe there's gonna be any other.

Subs directly to filter, but if there is that it applies to them as well the coworker.

You can dispatch ratios and also registering of core workers.

That's, I'm.

That's, that's about it for me.

Like I said, the filters been through this process for several times.

We're starting the first one, Mira Mesa on. I think the removal is on 6/16 and then they're going to come in and we'll have our other crew with our core employees and dispatching too from the operators, the do the regrade on 623. And then I think.

The following week is 4th of July.

And then they're starting the 2nd regrade on 7/7 after, so it's.

It's kind of spread out, but it'll be one week of work for operators and then a break and then another week of work for operators.

And yeah, that's what we're doing this year.
